 - Vendor is not permitted to set up and use sound amplification devices.
 - Vendor shall have 1 (ONE) Hour following the conclusion of Event (aprox. 7:00 PM) to dismantle and remove all items from the Venue. Vendor shall leave the assigned space free from trash/debris and in the exact condition prior to setup.
 - Vendor agrees to Hold Harmless the Host from any and all damages/claims in connection to the Vendor and its Staff's participation in Event.
 - Vendor WILL BE ISSUED 3 VENDOR PASSES --- ANY ADDITIONAL PATRON MUST PAY GENERAL ADMISSION.
 - Vendor acknowledges that this is a **NON--REFUNDABLE AGREEMENT** and no deposits/payments shall be reimbursed for any reason of cancellation by Vendor, except if the Event is cancelled by Host at which time you will be notified by the Host and/or Staff.
